Dear MCES Families,

In this packet you will find the following: Summer Camp Registration Form, Summer Program Schedule, Sunscreen & Walking Permission Form, and field trip permission forms. **Please fill out all forms and return them to Mrs. Reynolds. You will receive a confirmation email once Mrs. Reynolds has processed your paperwork. All Fees for Summer Camp will be billed through FACTS.**

- All forms need to be completed and returned to Mrs. Reynolds by Monday **May 20th, 2024**.
- There is a nonrefundable registration and supply fee of **\$60**. Registration after **May 20th, 2023 will increase to \$70**.
Pricing: Preschool & School Age Rates: **\$200 per week (\$40 per individual day)**

Each week, we will have many activities planned for the students. Some of our activities have additional fees. Please refer to our Summer camp calendars and permission slips for pricing.

Summer Billing will be planned as follows:

Weeks 1-3 will be sent out June 3rd Payment will be due June 28th

Weeks 4-7 will be sent out July 1st Payment will be due July 31st

Weeks 8-10 will be sent out August 1st Payment will be due August 30th

Due to student/staff scheduling and the purchasing of materials, **there will be no refunds for sick or absent days.** You will be charged for whatever days you elect on your Summer camp Registration form. Vacation days should be given to the director **with enrollment.**

Students will need the following for Summer Camp:

Please send in one container of sunscreen, with a minimum of 30 SPF (we prefer spray kind) to be used when spending time outside. Please inform us if your child has allergies or sensitivity to sunscreen and needs to have a particular kind of sunscreen applied. If this is the case, please label your child's sunscreen so we can apply it to him/her only. Please apply a first coat of sunscreen to your child in the morning before arrival to our program. The children will be spending a majority of their time outside playing every day.

All children need to wear secure athletic shoes and socks when attending our programs. They will be very active and do a lot of walking. **Sandals, flip flops, crocs, etc. may not be worn.** We encourage children to wear clothes that are comfortable and weather appropriate. Each child will need to pack a lunch, two snacks, and a refillable water bottle. Please send a lunch with your child that does not require refrigeration or a microwave and send plenty of water or a water bottle that can be refilled throughout the day. Please label all items that are brought in. In addition to packed lunch please provide your child with 2-3 additional snacks. * Snacks are not provided during summer camp.*

On Bike Day the children are able to bring their bike or scooter to camp to ride throughout the day. Students must have a helmet to ride in the parking lot. We will have a section coned off for the kids to ride. (No Skateboards, roller skates/blades or motorized scooters/hover boards)

On Water Day please have your child wear clothes that they can get wet including shoes. The children will need to pack a towel and extra clothes to change into after water time. We will have a sprinkler set up in the garden, water balloons, water tables, etc. for the children to enjoy outside.

Summer camp begins on Monday, June 10th. We will be closed on Thursday, July 4th in observance of the holiday. The last day of summer camp will be Friday, August 16th. There will be no care provided for preschool and school age children the week of August 19th-23rd in preparation of the 2024-2025 school year.
